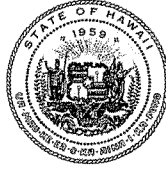

Dear President Hanabusa and Speaker Say:

Re: Plan to Eliminate the Unnecessary Collection
and Use of Social Security Numbers

Part VII, Section 11, of Act 10 (2008), requires all government agencies that collect, maintain, or disseminate documents containing personal information that are subject to disclosure pursuant to Section 92F-12, Hawaii Revised Statutes, to develop a written plan to eliminate the unnecessary collection and use of social security numbers. The Information Privacy and Security Council (IPSC), which is assigned to the Department of Accounting and General Services and chaired by the Comptroller, respectfully is submitting our report of compliance.
