a) Update from Committee: Review of existing PII protection strategies, protection Yong statutes, and potential updates.

- Member Yong discussed potential legislative updates. Discussion took place regarding Florida and California privacy updates that had taken place recently and potential benefits and security or systems impacts of the various options. A draft prepared by the committee was also discussed.
- b) Strategies, considerations, and discussion of current practices for the protection Chair and of PII on State systems.

OCP invited guests

- Invited Guest Bruce Kim from the Department of Commerce and Consumer Affairs, Office of Consumer Protection reviewed the existing State privacy protections and how they fit together, how they provide various protections, notification, and events of non-state entities.. Discussion took place on the implications and cautions of these to systems and data within the State.
- Executive Director Crosby discussed confidential findings furnished by another state's entity on a recent breach they encountered, the impacts, and methods / processes they used that were successful that could be beneficial in the State with the construction of both proactive and reactive frameworks.
- Review and discussion of Office of Information Management and Technology (OIMT) projects concerning PII and security of State systems
- Consideration of PII policy and development
  - Executive Director Crosby led a discussion on the reformation of a Policy Working group focused on security and privacy and weaknesses that need to be addressed.
- Messaging and Collaboration Project and protection of PII
  - Executive Director Crosby reviewed goals of the system configuration for protection, existing issues, and timelines.
- Digital Leakage Protection
  - Matthew Wong led a discussion and review of this ongoing project, the current focus areas, and the next areas of implementation. Discussion took place of the various potential weaknesses and how they may be proactively addressed.
- Government Private Cloud security issues
  - Matthew Wong led a discussion and review of this ongoing project, the current focus areas, and the next areas of implementation. Discussion took place of the various potential weaknesses and how they may be proactively addressed, as well as a confidential assessment that was completed.
