### I. Call to Order — Welcome

Acting Chair DeMello called the meeting to order at 1:04 p.m. Quorum was established with eight members present. Note: This 12-member Council requires eight members to establish quorum and take official Council action.

### II. Approval of Previous Meeting Minutes

Member Thornton moved and Member Yong seconded that the IPSC approve the November 2015 regular meeting minutes as amended. In discussion, members identified the following amendments:

- Page 2, paragraph three, change "publically" to "publicly"
- Page 3, paragraph two, line four, delete "on"; line five, change "acknowledge" to "acknowledging"; and line 10, make "report" plural

The IPSC adopted the regular meeting minutes as amended by unanimous consent.

# IV. IPSC Annual Summary Report, Pursuant to HRS Section 487N-5, on State and County Agencies' Submission of Personal Information System Annual Reports; Discussion and Appropriate Action

Members reviewed the latest draft of the IPSC Annual Summary Report. Final follow-up is being conducted with agencies who have not yet responded to IPSC's requests for: 1) their respective agency privacy designee and/or 2) their respective personal information (PI) system report or confirmation that the agency does not collect PI (as defined by the IPSC Annual PI System Report form that was provided to agencies to facilitate compliance). Acting Chair DeMello noted near full compliance among State and Honolulu agencies. The final report is due to the Legislature by December 31; any responses received before then will be reflected in the IPSC's final report to be submitted to the Legislature. Members Sherman and Jacobs requested lists of agency privacy designees for their respective counties.

# V. IPSC Report, Pursuant to S.C.R. 88, 2015 Legislative Session, on the Assessment of Existing Procedures of Notification Required Following the Breach of Personal Information; Discussion and Appropriate Action

Members reviewed a draft of the S.C.R. 88 report. Acting Chair DeMello noted that the Office of Consumer Protection expressed its intent to create a citizen-facing online breach information portal, as recommended by the IPSC. Members discussed the benefits of further investment in modernizing the process for annual collection of PI system reports, and that this should be added to the S.C.R. 88 report recommendations.

## VI. S.B. No. 1186, 2015 Legislative Session, Relating to Personal Information; Discussion and Appropriate Action

Members reviewed S.B. No. 1186 SD1 and a summary of amendments made in committee during the 2015 legislative session. To express the IPSC's continued support for the bill, it was recommended that the IPSC chair follow up with Senator Glenn Wakai (chair of the Senate Committee on Economic Development, Environment and Technology), who introduced the bill, as well as Senators Jill Tokuda (chair of the Senate Committee on Ways and Means) and Gilbert Keith-Agaran (chair of the Senate Committee on Judiciary and Labor), who chair the committees to which the bill was last referred.
