I. Call to Order

Acting Chair Hoang called the September 2017 meeting of the Information Privacy and Security Council (IPSC) to order at 1:06 p.m. Quorum was established with nine members/designees present.

II. Review and Approval of Previous Meeting Minutes

Member Tong moved for the IPSC to approve the August 2017 meeting minutes, and Member Yong seconded the motion. The IPSC adopted the minutes by unanimous consent.

III. Public Testimony on Agenda Items

IV. Status Report on the Collection of State and County Agencies' Submission of Personal Information (PI) System Annual Reports, Pursuant to Section 487N-7, Hawai'i Revised Statutes (HRS)

As approved at last month's meeting, the Chair's memorandum to remind agency privacy designees of the upcoming annual reporting deadline, as well as disseminate information about the Privacy Impact Assessment (PIA) online form and fillable PDF, was distributed on August 25. Links to the PIA Online Form and the fillable PDF are also available on the IPSC website (ipsc.hawaii.gov).

Although the deadline for agencies to submit their annual reports is September 30, it was reported that two reports have already been received via the online form and another nine have been received via email or hard copy. The reports are maintained in two separate, secure SharePoint folders based on how they were provided (online form vs. email/hard copy). Members discussed preferences for limiting access to view the reports. Currently, individual submitters of reports who are not members of the IPSC can only see their own submissions. IPSC members have universal access. IPSC members expressed preference for limiting access further so that members can only see reports from their jurisdictions. ETS will update access parameters accordingly.

V. Status Report on the Department of Public Safety (PSD) Hawai'i Correctional Industries' Digital Scanning and Archival Services

In 2017, the PSD Hawai'i Correctional Industries launched a program providing digital scanning and archival services. Information about the program is available at: http://hawaiici.org/Site/catalogs/scanning/scanning.htm

As previously reported, ETS has received a preliminary briefing from the department affirming that processes are in place to safeguard information. A follow-up site visit is still being scheduled to provide an opportunity to evaluate those processes. Member Keane has expressed interest in participating.

VI. Status Report on the European Union General Data Protection Regulation

This item is on the agenda to provide the opportunity to discuss the GDPR, a regulation by which the European Parliament, the Council of the European Union, and the European Commission intend to strengthen and unify data protection for all individuals within the European Union. The GDPR also addresses the export of personal data outside the EU. It goes into effect May 25, 2018. More information is available at: http://www.eugdpr.org
