IV. Permitted Interaction Group's (PIG) Report and Recommendations on the Privacy Impact Assessment (PIA) Form

PIG members consisted of Hoang, Keane and Thornton. They reviewed the PIA form and recommended keeping the form as is for now and focus on reducing and safeguarding the personal information that is being kept. Next steps would be to identify agencies that have personal information, develop procedures to identify the information on hand, review if the data needs to be maintained or if it can be reduced or eliminated, and then identify key controls that are missing to improve the safeguard of those systems.

Member Norman requested a completed form to use as a sample template to help newly-appointed department heads and staff complete the PIA form. Hoang will provide her with a sample. Hoang will also send members their administration contact list to update. The contact list will be used to issue the memo to agencies regarding submittal of its annual Privacy Impact Assessment form.

Related to House Concurrent Resolution (HCR) 225, Hoang stated that there is a separate initiative to review privacy laws that match the General Data Protection Regulation (GDPR) and the California Consumer Privacy Act (CCPA). He asked members if they are interested in developing draft legislation that will align with IPSC's PIA form. Member Yong volunteered to help. Member Designee Tong felt it was premature to introduce legislation at this time.
