I. Call to Order

Quorum was established and Chair Hoang called the meeting to order at 1:10 p.m.

II. Review and Approval of the November 18, 2020 Meeting Minutes

Chair Hoang called for a motion to approve the minutes. Member Chee made a motion to approve the meeting minutes, which was seconded by Member Thornton. A vote was taken, and the motion passed unanimously.

IV. Annual Personal Information System Report; Discussion and Appropriate Action

- Proposed Revision to Privacy Impact Assessment (PIA) Form

Chair Hoang presented the proposed revisions to the Annual Personal Information System Report, Privacy Impact Assessment (PIA) form. Recommendations from previous IPSC meetings were incorporated into a draft form. The purpose of the changes is to increase clarity and simplify the form for responders and for improved data analyses. Cyber Liability Insurance (CLI) related additions were also proposed.

Chair Hoang made a motion to approve adoption of the revised form including the CLI additions for use starting summer 2021. The motion was seconded by Member Giardina. A vote was taken, and the motion passed unanimously.

Member Ito asked if UH can use the PIA questions to prepare their online form, and Chair Hoang affirmed they could.

V. 31st Legislature; Discussion and Appropriate Action

There are currently no bills for consideration by the IPSC; however, Chair Hoang commented that the Office of Information Practices (OIP) proposed an amendment to the Sunshine Law that would affect how IPSC meetings are conducted.
