I. Call to Order

Quorum was established and Chair Hoang called the meeting to order at 1:01 p.m.

II. Review and Approval of the March 17, 2021 Meeting Minutes

Chair Hoang made a motion to approve the meeting minutes, which was seconded by Member Giardina. A vote was taken, and the motion passed unanimously.

III. Public Testimony on Agenda Items

IV. Annual Personal Information System Report; Discussion and Appropriate Action

- Finalize Logistics and Timelines

Chair Hoang recapped the finalized timeline for report gathering:

- 1) July 2021 – ETS will email a memo reminder to the agencies.
- 2) August 2021 – IPSC members will send a reminder to their respective agencies.

3) September 2021 – ETS will send a final reminder to the agencies.

Chair Hoang surmises the most difficult pieces for completing the report will be identifying the location sources and the records. However, he reminded the council that the form was simplified for ease of reporting. The assessment is not for seeking the quantity of personal information collected but rather the scale or range. This will simplify the data analytics and reporting.

- Review Distribution Contact Lists

Chair Hoang said that after today's meeting, the current contact lists for their respective agencies will be sent to IPSC members for review and revision as necessary.

Chair Hoang asked if any council members had any concerns regarding the logistics, timelines, or contact lists. No concerns were noted.

#### V. Good of the Order

Chair Hoang asked if the members had any comments or concerns. No comments were given. The CISO commented on the recent ransomware issues in the national news, and a White House executive order was issued. Explicitly recommended are multifactor authentication and end point detection. Chair Hoang offered to provide a summary of the executive order to any council member who requests one.
