I. Roll Call

Chair Hoang took the roll call and called this IPSC meeting to order at 1:35 p.m., confirming enough members for a quorum.

II. Review and Approval of the September 17, 2025, Meeting Minutes

Chair Hoang made a motion to approve the September 17, 2025 meeting minutes, which was seconded by Member Courtney and carried by a majority vote.

III. Public Testimony

None.

IV. [Annual Privacy Impact Assessment \(PIA\) Process](#)

The annual privacy impact assessment process and summary report were reviewed. Member Courtney raised a concern regarding a missing submission from the City and County of Honolulu. Chair Hoang acknowledged the issue and recommended reviewing and correcting the report before finalizing it for submission to the legislature. He explained how the information was collected may impact us to go further and provide more guidance. Since no further comments or recommendations were provided by the members, Chair Hoang called for a motion and vote for such correction, which was seconded by Member Ito. All members were in favor and the motion carried unanimously.

V. [Hawaii Public Sector Cybersecurity Summit 2025](#)

The Hawai'i Public Sector Cybersecurity Summit was held on December 3, 2025. Members from the government, local, state and federal met to convene. It was the inaugural event led by ETS and supported by e.Republic. Chair Hoang and members appreciated the event and its keynote, despite some humorous remarks. Chair Hoang emphasized the importance of in-person meetings and maintaining year-round discussion.

Member Courtney brought up a question to Chair Hoang and discussed the transition period membership fees and their affordability. Member Courtney expressed a preference for the State funding due to financial challenges. Other members from Maui and Hawai'i counties mentioned paying for their memberships separately. The conversation also touched on the importance of maintaining statewide support for the MS-ISAC (Multi-State Information Sharing and Analysis Center) membership.

Chair Hoang discussed with the members the importance of multi-factor authentication (MFA) for both enterprise and citizen engagement through the myHawaii program. He explained the transition to phishing-resistant MFA options like passkeys and emphasized the use of SAML (Security Assertion Markup Language) and OIDC (OpenID Connect) protocols for secure logins. Chair Hoang encouraged agencies to collaborate with the ETS team for further details and implementation.

Chair Hoang pointed out the challenges of securing public meetings to ensure smooth member participation. He mentioned successful onboarding of members, some configuration issues, and the need to improve login and participation capabilities. Member Courtney expressed gratitude for resolving previous technical problems. Member Stone thanked Chair Hoang for addressing these issues.

Member Courtney stated the improvements made for better meeting experiences. Chair Hoang suggested technical recommendations for securing public meetings and mentioned working with the Office of Information Practices. Member Stone shared Hawai'i County's experiences with Zoom and Teams for public meetings.
