I. Roll Call

Chair Hoang called the meeting to order, confirming enough members for a quorum, at 1:36 p.m.

II. Review and Approval of the February 18, 2026, Meeting Minutes

Chair Hoang shared the agenda and link to the meeting minutes in the Chat, then paused to allow attendees to review them before making a motion to approve. Member Ito seconded the motion, and minutes were voting unanimously in favor.

III. Public Testimony

IV. 2026 Legislative Bills

Chair Hoang highlighted [Senate Bill \(SB\) 3016](#) relating to privacy, provided the update that it passed the second reading but was uncertain of further progress, and invited comments from members. No comments were made from the members.

V. [Annual Privacy Impact Assessment \(PIA\) Process](#)

Chair Hoang explained that ETS had reviewed the draft bill language and was working to streamline the Privacy Impact Assessment (PIA) process to improve governance. The focus was placed on conducting targeted PIA reviews specifically for critical applications, with plans to report feedback from these reviews back to the Information Privacy and Security Council (IPSC). No additional feedback was provided by the members during this discussion.

VI. Secure Access Service Edge (SASE)

Chair Hoang provided an overview of Secure Access Service Edge (SASE) technology, highlighting its advantages compared to traditional VPNs and its alignment with zero trust security principles. He stressed the importance of addressing performance challenges specific to Hawaii, recommending the selection of vendors with a local on-island presence to ensure optimal service. Chair Hoang also advised conducting an inventory of existing VPN technologies as part of considering a transition to SASE, and offered support for evaluating potential vendors and products. No additional comments or questions were raised by the members at this time.

VII. Good of the Order

Chair Hoang announced two upcoming cybersecurity events: the Annual Interface Conference and the Cyber Hawaii annual conference. Member Ito provided clarification on the dates for the FBI conference and also mentioned the Gov Tech AI Summit. With no additional events brought forward, Vincent invited suggestions for future meeting agendas, and none were offered at that moment. Chair Hoang reminded that the next
