- IV. 2026 Legislative Bills
 - a. [Senate Bill \(SB\) 3016](#) - Relating to Privacy. Adds definitions of "identifier" and "specified data element" and amends the definition of "personal information" for the purposes of notifying affected persons of data and security breaches under the State's data breach notification law. Includes telecommunications carriers subject to and in compliance with certain federal provisions among the businesses deemed compliant with this law. Effective 7/1/3000. (HD1).

- V. [Annual Privacy Impact Assessment \(PIA\) Process](#)
 - a. Any government agency that maintains one or more personal information (PI) systems must submit to the IPSC an annual report on the existence and character of each PI system added or eliminated since the agency's previous annual report, pursuant to HRS §487N-7. Annual reports are due no later than September 30 of each year.

- b. Discussion on agency implementation.

VI. Secure Access Service Edge (SASE)

- a. SASE is a cloud-native technology that follows [Zero Trust](#) principles from the National Institute of Standards and Technology (NIST) and combines several security services including cloud access security broker (CASB), secure web gateway (SWG), remote browser isolation (RBI). In particular, the technology uses [Zero Trust Network Access \(ZTNA\)](#) to replace virtual private network (VPN) for remote workers, which have been repeatedly targeted by threat actors to compromise organizational networks.
